This is to remind you that the final instalment for this trip (£60) is due the week after half term – Monday 31st October – Friday 4th November There are a few people who are behind on payments, some having now missed 2 payments which is putting us in a precarious situation with the tour company. Therefore, they need to bring in the full amount by 4th November without fail please. This is vitally important as I have to send off the balance at the end of November and if we have not got enough money in the account to cover this payment the finance office will not be allowed to send the balance, which could endanger our booking. Here is a reminder of the summary of the payment schedule:

March - First deposit - £100 - already paid

A 2nd deposit of £75 must be paid between Monday 20June and Friday 24 June – see below for details about paying

Third payment - £75 to be paid between Monday 12 September and Friday 16 September

Final payment - £60 to be paid between Monday 31st October and Friday 4 November

I am also sending you some medical forms and a behaviour contract which need to be completed and brought back to school by Friday November 4th at the latest. It is essential I have all the information requested for insurance purposes.

.There is also a kit list attached – please note that old track suits/jogging bottoms and trainers will be ideal for our outdoor activities so if you are buying new items over Christmas please don't throw old ones out! No specialist equipment is needed but sleeping bags will be required.

When the trip was launched it was stipulated that the place on the trip would be dependent on satisfactory behaviour up to the trip departing and that pupils may be withdrawn from the trip in the event of persistent bad behaviour which could lead to financial loss for the parents/carers. Could you please discuss the importance of following instructions and obeying rules in the light of this as I would not like to have to remove people from the trip.
