## **Re: Exam Results Information**

We are writing to you to give you an update regarding your child's upcoming GCSE results. Over the last fortnight, you will have received a letter outlining the process to follow should your child be unable to collect their examination results on Thursday 12 August.

We are now able to inform you of the times and procedures for the collection of the results (this may be subject to change dependent upon government restrictions due to COVID, still in place at the time). Details of any changes will be sent to you as soon as possible (please check the school website regularly for information).

All students have been issued time slots in form groups, please see the table below:

If your son/daughter is unable to attend their allocated time slot, **it will not** be possible for them to move to one of the other two slots. They can however attend later that day between the hours of 11:00am and 12:00pm where staff members will still be on site to issue the results.
