Parental Commitments

1. Attendance, punctuality and holiday arrangements

I shall do all in my power to ensure that my child attends school in all but exceptional circumstances and on time. I recognise the importance of attending school and so agree not to take my child out of school on holiday during term time. Should exceptional circumstances arise, I agree to discuss the matter with the Achievement Leader/Assistant Achievement Leader before making any firm booking. I also recognise that non-medical absence from school will normally be treated as unauthorised.

2. Discipline and sanctions

I support the school's efforts to create and protect a safe and positive environment in which all children can thrive. I shall therefore do all I can to support the school's behaviour systems and to help ensure that my child faces up to the consequences of their actions. I understand that a slip will be issued, or phone call made, to inform me of any after school detention and when it will take place and that the onus is on my child to pass on the detention slip to me. I recognise that legally the school no longer has to provide 24 hours notice for after school detentions, although unless there are exceptional circumstances then the school will endeavour to still do this.

3. Journeys to and from school / visits and trips

I understand that the school's behaviour policies cover my child's journeys both to and from school, when on a school trip, or indeed anytime that they are out in public in school uniform. I also recognise that behaviour is a key measure when determining suitability of students for school trips.

4. Uniform and mobile phones / digital devices policies

I agree that my child will abide by the school's Uniform and Mobile Phones/Digital Devices Policies, which includes the confiscation of the phone/device (Copies of these are available on the school's website www.hungerhillschool.com or directly from the school).

5. Worries and Concerns

I accept that there may be times when difficulties arise in relation to my child's education. I therefore agree to discuss any such matters with school at the earliest possible time in order to keep the school informed.

6. Parents' Evenings / information evenings

I recognise the importance of understanding how well or otherwise my child is doing with their work. I shall therefore endeavour to attend the annual Parents' Evenings and offered information meetings.

7. Communication

I understand that unless I have a prior agreement (e.g. with a Special Educational Needs Support Officer), should I want to speak to a member of school staff I should initially make contact by telephone, or by email, making an appointment if necessary. To help facilitate good communication with school I will check and sign my child's planner each week, using the planner as a means of communication with the form tutor. I also understand the importance of prompt correspondence when returning reply slips from letters, newsletters, reports, or other information which is sent home.

8. Homework

Homework enhances student learning, improves achievement and develops students' study skills and as such is an integral part of the curriculum. I understand that the school will set regular homework and I will support my child in meeting deadlines. I understand that non-completion of homework will result in consequences such as detentions.
