Re: Year 8 Parent Survey

At our recent Year 8 Subject Teacher Parents Evening we invited parents to complete our Parent Survey. The feedback from all stakeholders is essential as it informs our strategic planning and provides us with vital evidence of the impact of the work being undertaken throughout the school.

Over 70% of our families attended on the evening and 60% responded to the survey either on the night or in the following days. We are grateful to all parents and carers that took the time to provide their feedback, a summary of findings from which are below. We have also attempted to respond to some of the queries and where appropriate individual contact has been made with parents.

| 4. | My child has been bullied and the school dealt with it quickly and effectively | Reassuringly most responses indicating that their child had not experienced any form of bullying at school. However, where it was indicated bullying had occurred, only four responses 'strongly disagreed' that the matter had dealt with quickly and effectively. |
| 5. | I am aware of what my child will learn during the year | 93% responded Agree or Strongly Agree |
| 6. | When I have raised concerns with the school they have been dealt with properly | Of the respondents who stated they had raised a concern, two felt that the matter had not been dealt with properly |
| 7. | My child has SEND, and the school gives them the support they need to succeed | Of the respondents of parents of a child with a SEND, no parents strongly disagreed that the school doesn't provide appropriate support |
| 8. | The school has high expectations of my child | 96% responded Agree or Strongly Agree |
| 9. | My child does well at Hungerhill | 95% responded Agree or Strongly Agree |
| 10. | I am aware of how well my child is doing | 96% responded Agree or Strongly Agree |
| 11. | There is a range of subjects available to my child at Hungerhill | 95% responded Agree or Strongly Agree |
| 12. | My child can take part in clubs and activities at Hungerhill | 94% responded Agree or Strongly Agree |
| 13. | Hungerhill supports my child's wider personal development. | 93% responded Agree or Strongly Agree |
